IN OUR FIRST YEAR OF MOSAIC FAMILY HEALTH WE MET MANY GOALS CENTERING AROUND OUR MISSION OF CARING FOR PATIENTS, DISCOVERING KNOWLEDGE, TEACHING PHYSICIANS, AND SERVING THE COMMUNITY. WE CONTINUE TO HOUSE AND TRAIN 21 FAMILY MEDICINE RESIDENTS. WE GRADUATED 6 RESIDENTS IN JUNE 2016 AND ADDED 7 NEW ONES. WE PROVIDED 20,000 APPOINTMENTS TO PATIENTS BETWEEN PHYSICIAN, LAB, X-RAY, PSYCHOLOGY AND NURSING VISITS. WE CONTINUE TO SERVE SOME OF THE MOST VULNERABLE PATIENTS IN OUR COMMUNITY AND ARE ABLE TO HELP THEM MEET MANY OF THEIR BASIC NEEDS WITH ASSISTANCE FROM OUR IN-HOUSE CARE MANAGER. IN OCTOBER OF 2015 WE HIRED A SOCIAL WORKER WHO WAS TRAINED BY THE ROSALYNN CARTER INSTITUTE TO PROVIDE CASE MANAGEMENT FOR CAREGIVERS OF PEOPLE WITH DEMENTIA. THIS IS A 2 YEAR GRANT THAT WE HOPE WE WILL BE ABLE TO SUSTAIN TO HELP OUR AGING COMMUNITY. OUR FACULTY PHYSICIANS CONTINUE TO GROW IN THEIR KNOWLEDGE AND PRESENT AT MANY NATIONAL CONFERENCES THROUGHOUT THE YEAR. PLUS CONTINUE TO DO LOCAL EVENTS.
