Concordia Community Support Services (CCSS) program service accomplishments are a testament to the mission and vision that guides the actions of those we employ, "to serve our aging community with a continuum of high quality caregiving options, provided in a Christian environment, and to serve those with limited funds to the best of our ability." CCSS manages the leadership and operations of Concordia Visiting Nurses, Alliance Visiting Nurses, dba, VNA Alliance, Good Samaritan Hospice of Pittsburgh, Concordia Hospice of Washington and Concordia Private Care. All of these entities are 501(c)(3) (one of which is applied for) non-profit entities. The care provided by the employees of these organizations goes far beyond the healthcare medical services in which we specialize. Patients and families are educated and supported through disease management as well as situations related to caring for a loved one who is aging. At CCSS, our faith in God is what motivates us to serve His people. The organization is committed to mentoring and teaching, therefore, providing the highest quality of care to not only our patients but also to our employees and the members of the community in which we serve. Employees are offered training and opportunities to obtain new skills such as Wound Care Certification, Palliative Care Training, IV Therapy Certification, Lymphedema Therapy Certification, and Hospice Boot Camp Training. Executive leadership completes an educational topic to college students at Slippery Rock University regarding the healthcare landscape we face in an ever-changing environment. Bible study opportunities are offered to employees and members of the community bi-annually. Weekly a TOPs (taking off pounds sensibly) meeting is open to employees and members of the community to offer tools and programs for healthy living and weight management. Educational radio shows broadcast 4 times a month in Beaver, Butler and the New Castle areas. Sample topics include: * Will Medicare pay for home health care * Preventing falls for seniors * Making medical decisions in a crisis * Getting pneumonia in the hospital, tips for care and what to watch out for * What to do after a heart attack * Preventing and treating pneumonia * It's flu season, what to know * Bed sores and what are they * Important medical papers you should keep safe * How to report medical symptoms to your doctor. Employees gathered supplies and created kits to provide to homeless individuals within our communities. Over 100 kits were put together to give homeless in our communities toothbrushes, soap, razors and other common necessities. CCSS also participated in a food drive with ALIVE! Community Church. Sarver to help those in need in our community to have a meal for Thanksgiving. Leadership served at Katie's Kitchen, St. Mark's Lutheran Church in Butler. The kitchen provides a free meal every Thursday. Individuals participate in serving the meal and cleanup afterwards. Members of the CCSS management team participate in "Make a Difference Day" with St. Luke Lutheran Church in Cabot. We gathered with a common mission "to improve the lives of others." Some opportunities to serve during this mission project included: * Raking leaves for homebound elderly in the community * Home repair for homebound elderly in the community * Mulching for the community trails to trails walking/biking trail * Cleanup for the local humane society * Preparing meals for the local meals on wheels program. Concordia Community Support Services makes cash donations to various other 501(c)(3) organizations totaling \$1,350,000. The donations are used to further the mission of caring for God's people either through charitable care that supports patient's needs or to better serve both domestic and foreign communities through Christ-centered programs.
