In FY15-16, College Beyond provided direct coaching and support to over 150 students to complete financial aid applications, complete the enrollment steps to college, and find first-year success. As a result individualized coaching, text-message interventions, emergency micro grant funding, peer mentorship, and a student-centered outcomes-based approach, 96% of students completed financial aid applications (vs. 59% citywide), 78% enrolled in college (vs. 47% district-wide), and 66% persisted from the first to second year of college (vs. 32% district-wide).
