PCC Foundation was created to separate certain considerations from PCC's general operations as a federally qualified health center, including (1) isolating certain real estate activities and liabilities from PCC's overall charitable activities and assets, (2) separating certain financing and fundraising considerations from PCC's general operations as a federally qualified health center, and (3) allowing for more financial and fundraising talent to participate in PCC fundraising efforts. PCC Foundation will engage in fundraising efforts to solicit charitable donations for PCC, most significantly the coordination of an annual gala.
