SHELTER AND FOSTER CARE - THE HOME SERVES CHILDREN AND YOUTH FROM INFANCY TO AGE 21, AS THE ONLY AGENCY TO PROVIDE EMERGENCY AND TEMPORARY CARE FOR ABUSED, NEGLECTED, OR ABANDONED CHILDREN IN SEDGWICK COUNTY. THE CHILDREN'S HOME PROVIDES SAFE ENVIRONMENTS THAT ALLOW CHILDREN THE OPPORTUNITY TO BEGIN HEALING FROM THEIR TRAUMA. CHILDREN AND YOUTH MAY BE ADMITTED BY LAW ENFORCEMENT OFFICERS, SOCIAL WORKERS, PARENTS AND THE YOUTH THEMSELVES. THE RESIDENTIAL DEPARTMENTS PROVIDE SHELTER SERVICES FOR YOUTH FROM 13 TO 17 YEARS OF AGE.
