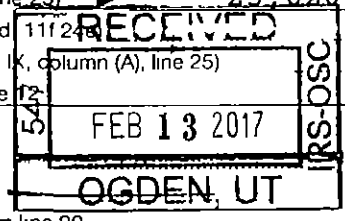

Pregnancy, parenting and adoption services give young mothers the support and incentives they need to become self-sufficient and nurturing parents, or to create an adoption plan. The adoption process is the start of a life-long relationship between birth parents adoptive parents and a child.

Pregnancy support was provided for 53 single pregnant women.

All 9 women in the Teen Moms Program had a mentor, and 5 of the women met with their mentor for at least 8 hours. All 5 non-graduated students in the Teen Moms Program remained in high school. All 7 of the women who set goals in the Teen Moms Program completed 50% of her

Family strengthening programs provide relationship and marriage education classes to help individuals and couples learn relationship-building skills that benefit both themselves and others. Also, counseling for addiction or relapse prevention helps individuals and families develop habits and behaviors for happier success in all areas of life.

127 individuals completed Healthy Relationship Classes.

Two new counselors joined the staff, addressing a wide range of counseling needs. Together, all 3 counselors completed 147 intake assessments for the year. On average, each counselor maintains 25 open

Family sustaining programs strive to connect individuals and families with resources such as housing, utilities, food, and other essential supplies to meet their basic needs.

The transitional housing program stabilized and improved life for 65 people.

7 mentors worked with 30 unincarcerated individuals, providing support and strength to turn their lives around.

A new financial education program for women provides education and matching dollars for money they put into savings.
