It is characterized by advocacy, communication, and resource management and promotes customer accountability. Community collaborations are a necessity to the success of the customer. Over 200 partnerships have been established and are maintained by the community support staff. Over 4,000 individuals and families have received a service. Participants may be involved in the project for up to 24 months. In some situations the full amount of time may be needed due to the disability acceptance and confirmation of social security benefits, waiting periods for low-income or See Form 990, Page 2, Part III, Line 4a (continued)

Transitional Housing provides temporary housing for homeless individuals and families.
