STARBASE funding is part of the Foundation's Grants to Leavenworth USD 453 totaling \$198,310. These grants ranging in amounts from \$159 to \$10,000 provides teachers and staff much needed resources to enhance overall learning experiences by introducing innovation and experimentation in the classroom.

Students will learn and perform on the instruments within the percussion section. Percussionists will come from all who are musicians or want to learn to become one. Students in this ensemble will perform as a group, but also as part of the larger Warren Middle School band and choir programs.

The White House Decision Center is an education program to provide students with the opportunity to work through one of four simulations of real-world events that occurred during the Truman Administration. Through role-playing, the simulations are designed to emphasize information gathering and analysis, problem solving, decision making, leadership, communication, group learning, the interpretation of original historical documents, and knowledge of history and government.
