SCWIB provides workforce development opportunities and resources in an eight county region of south central Pennsylvania. The SCWIB oversees six Pa Careerlink Offices for job seekers and employers as defined in the Federal Workforce Investment Act. The SCWIB focuses on contracting with programs that enable employees, dislocated workers, EARN participants, and youth to attain the job skill competence required by employers.

The organization expended Federal Workforce Investment Act formula Title 1 and discretionary grant funds to enroll 1,652 adult, youth, and dislocated workers in job training and development services. Rapid Response, core and intensive job search and development activities were provided for major layoffs in the eight county south central region of Pennsylvania. Eligible participants services included workshops, on-the-job training and skill specific training. Initial core service and eligibility determination and assessment occur at any of the six One Stop Centers( Careerlinks) within the eight county region in accordance with the WIA and WIOA Act. Program services fund Title 1 sub-contractors providing case management, individual skills training, tuition, and on-the-job reimbursement. Eligible participants served included: 395 In-school youth and 235 Out-of-School youth. Rapid response individuals impacted by major layoffs, adult and dislocated workers: 150 adult and dislocated workers received tuition based training or on-the-job training and rapid response events were held for employee layoffs under the WARN notifications. Youth placement rate is 60%, adult retention rate is 87%, and the dislocated worker job retention rate is 92%, all meeting State performance goals.

Federal and State grants awarded to subcontractors to enroll 791 welfare TANF adult participants and joint jobs initiative programs over the twelve month fiscal period. 42% or 335 participants claimed job placements of 20 or more hours per week. The measurable job retention rate was 55.3% of those placed who retained jobs for six months July 1, 2016 and thereafter. Work activities programs such as work experience for enrollees were funded.

Current year board meetings start in August of 2016 during the fiscal year end closing June 30, 2017. The next board meeting is scheduled

May 18, 2017, where the 2015 Form 990 and FYE 6/30/2016 audit will be presented. SouthCentral Workforce Board has a Single

Audit and Financial Audit performed following the financial year close due to most revenues are federal grants per OMB Super Circular.

The conflicts of interest forms are distributed annually to all board members and must be completed and submitted by May 1st of each year.
