The grantee organization must also have the capacity to fulfill the terms of the grant and be willing to furnish the foundation with any required evaluative reports. For grants originating from donor-advised funds, each grantee is instructed in writing that no one associated with the fund may receive any personal benefit because of the grant, and that the grant must be used for charitable purposes only. Depending upon the size and source of the grant, a written report from the grantee may be required.
