WOW 2015-The Women's Ordination Conference (WOC) hosted an international conference, "Gender, Gospel, and Global Justice," in Philadelphia, PA, bringing together more than 500 advocates for women's ordination from 18 countries. Three days of speakers, panels, workshops, liturgies and public witness made history as the first conference of its kind in more than 10 years. Scholars and experts offered lectures on feminist theology, interfaith perspectives, violence against women, male allies, and institutional racism, sexism, and clericalism. The conference was followed by a public witness in Philadelphia, days prior to Pope Francis' US visit there. WOW 2015 was covered widely in the media and brought global attention to the work for gender equality in religion.

Educational Outreach-WOC regularly publishes and shares advocacy, activist and educational resources for activists and members to enable local organizing and community building among our grassroots networks. Toolkits, media training and messaging, blog posts, and social media tools are widely dispersed. Also, our magazine, New Women New Church is published twice a year. Each issue is distributed to more than 2,500 members, donors, and subscribers. The newsletter contains information relevant to the issue of women's ordination into an inclusive and accountable Catholic Church. It informs readers about resources available to them and regional events across the country in which they can participate and support.

Three Ministries-The projects of WOC's Three Ministries are the central focus of the organization. The Ministry of Irritation works to raise awareness about women's ordination with public advocacy, such as prayerful demonstrations at major Catholics events. This year, a major component of this action was the Jubilee for Women Priests in Rome, which included a roundtable discussion with global scholars, a witness outside of St. Peter's Basilica, and a public art exhibit of more than 100 posters officially hung by the City of Rome, around the Vatican neighborhood. Our on-going initiative in Rome provides WOC the opportunity to attend several Vatican events centered on women in the church and church reform.

The Women's Ordination Conference (WOC) hosted an international conference, "Gender, Gospel, and Global Justice," in Philadelphia, PA, bringing together more than 500 advocates for women's ordination from 18 countries. Three days of speakers, panels, workshops, liturgies and public witness made history as the first conference of its kind in more than 10 years. Scholars and experts offered lectures on feminist theology, interfaith perspectives, violence against women, male allies, and institutional racism, sexism, and clericalism. The conference was followed by a public witness in Philadelphia, days prior to Pope Francis' US visit there. WOW 2015 was covered widely in the media and brought global attention to the work for gender equality in religion. A performance evaluation of the Executive Director/s shall take place within (60) days prior to the spring board meeting. The Board Vice President will be responsible for initiating and managing the process. The electronic Performance Management Form (Item IV of Appendix III) which follows will be utilized as a tool to set goals for the upcoming fiscal year and to evaluate the previous fiscal year. The Vice President schedules an Annual Evaluation meeting with the Executive Director for a time during last 20 days of the fiscal year, but no later than June 30. The Vice President then assembles all of the comments from the Board of Directors and the Employee Survey Form into the Performance Management Form, and the Board President, Vice President and Executive Director meet in person or by agreed upon virtual means for the annual evaluation to review the Performance Management Form. The Finance Committee determines a maximum salary increase for the Executive Director which is considered in the context of the state of the annual budget. This information is shared with the Board of Directors at the June meeting at which time the board officers discerns the appropriate salary action related to cost of living, merit, etc. The salary increase is voted on and at the earliest possible time after the increase is approved, the Executive Director is informed. The new salary amount will take effect July 1.
