PERMANENT HOUSING AS QUICKLY AS POSSIBLE AND CONTINUING TO WORK WITH FAMILIES ONCE THEY ARE IN PERMANENT HOUSING ONCE THE FAMILY ENTERS THE SHELTER, THEY ARE IMMEDIATELY ASSESSED FOR MAJOR HOUSING
