Senior -friendly door-to-door transportation, 5 day/week utilizing 8 mini-buses in FY 16 for seniors and non-elderly with disabilities to access essential needs. Action in Maturity (AIM) provides 56,160 rides to 2,746 unduplicated individuals.

Personal Transportation (12% of programming)

Transportation by request, a personal door-through-door transportation. AIM provides 4,751 rides to 199 individual other adults and people with disabilities.

4c (Code:) (Expenses \$ 92,121 including grants of \$ 98,726) (Revenue \$ 11,981)

Social Support Services/ Activities (17% of programming). Grants include contributions of \$18,521.

AIM reached out to 4,031 older adults and non-elderly with disabilities, mostly low-income women, with social services and health education: utility and medical subsidy assistance, farmers' market coupons, housing modification and repairs, legal and financial counseling, health screenings, flu shots and education, evidence -based programming, exercise classes, social /recreation events, and distribution of fresh and non-perishable food and pet food.
