YOUTH CONFERENCES: Youth conferences are held on a university campus with a number of students concurrently enrolled in the HISPA Role Model Program. Themed "Take Action! Achieve Your Dreams," conferences emphasize the importance of high school, inspire students to go to college, and introduce potential STEM studies via highly-successful Hispanic speakers and hands-on workshops.

In 2015-16, HISPA held three, day-long youth conferences at : 1) Columbia University in New York, NY; 2) St. Mary's University in San Antonio, TX; 3) Princeton University in Princeton, NJ. Approximately 255 volunteers and 386 students from 16 schools participated in these conferences.

ROLE MODEL/FELLOWS PROGRAM: The HISPA Role Model Program places Hispanic professionals in public schools and educational programs to eradicate one reason why Hispanic students do not pursue higher education and high-skilled careers: a lack of role models. Success of the Role Model Program requires the engagement, recruitment, and training of Hispanic professionals.

Accomplishments include:

Role model engagement and training: In 2015-16, HISPA engaged and trained role models through lunch and learn corporate presentations, individual coaching, educational public speeches, media publications, internet campaigns and webinars. In addition, HISPA hosted three formal role model training and recruitment events. The Fellows Program also prepared 39 Hispanic college students to be role models through eight day-long professional and leadership development workshops hosted at partner locations.

Program execution: During each classroom visit (six per school, per school year), two role models representing public/private sector careers relate cultural, educational, and professional experiences and events key to their success. In 2015-16, HISPA mobilized 73 volunteers to make 110 school visits, reaching 1,209 students in 15 partner schools. Role models from three organizations also welcomed 91 of these students to visit their corporations and learn more about possible career opportunities. After participating in the Role Model Program, 96.5% of 207 students surveyed reported that they were inspired to set college as a goal, and 70.1% reported that their interest in attending college increased.

App development workshops: This specialized component of the Role Model Program concluded in June 2016. In 2015-16, 12 two-hour workshops engaged 77 students in developing 14 apps and mastering 92.4% of workshop objectives (i.e., app development, design, programming skills). 86.7% of students surveyed reported that participating in this program inspired them to do better in other classes and 100% said it made them more interested in continuing education in STEM.
