The LifeFlight Foundation (LFF) supports LifeFlight of Maine (LOM) in the provision of emergent critical care medical services to patients needing specialized care throughout the entirety of Maine. LOM provides services to critically ill and injured patients regardless of insurance coverage and ability to pay for the cost of medical care. LFF provides capital support for aircraft acquisition, specialized medical equipment used on LOM helicopters and ground ambulances, emergency aviation infrastructure improvements such as hospital helipads, automated weather systems, and low level instrument flight infrastructure, and, support for a statewide High Fidelity Simulation continuing medical education provided by LOM to physicians, physician extenders, nurses, paramedics, and emergency medical technicians

The LFF supports a wide range of continuing medical and safety education. In FY2016 LFF provided financial and management support for the human patient simulator project run by LOM in partnership with the Maine Department of Public Safety Emergency Medical Services Bureau. The simulation program is used by hospitals and EMS agencies throughout Maine for continuing medical education to improve the care of critically ill and injured patients with a special focus on children. In FY2016, the Foundation helped to support LifeFlight in the provision of HPS programs for 437 physicians, Nurse Practitioners/PAs, emergency department and ICU RNs, Respiratory Therapists, Paramedics, and emergency medical technicians. In addition, the Foundation, working with LifeFlight and Pediatric Intensive Care Unit physicians from Maine Medical Center and Eastern Maine Medical center supported 2 Day long conferences at hospitals focused on the care of critically ill and injured, with 40 Emergency Physicians, Nurses, and hospital based paramedics. The Foundation also supported multiple public education events throughout the State.

The LFF supports the safety and availability of LOM services through a private-public partnership with the State of Maine and the Federal Aviation Administration. In FY2016, the LFF supported multiple aviation infrastructure projects including: a) the maintenance support for 14 automated weather observation systems (AWOS) located at rural airports and hospitals which are used by general aviation operations and the National Weather Service, communities include Vinalhaven, Belfast, Machias, Princeton, Fort Kent, Jackman, Greenville, Carrabassett, Skowhegan, Farmington, Rumford, Bethel, Eastport, and Brunswick, b) the installation of AWOS stations at Bridgton Hospital, Central Maine Medical Center in Lewiston, Matinicus Island and Monhegan Island, c) technical and consulting support for new hospital helipads at MaineGeneral Medical Centers in Augusta, Waterville, and Maine Medical Center in Portland, d) design and development support for a new helipad at Blue Hill, and e) the maintenance of 39 helicopter instrument flight approach and departure procedures at hospitals, communities, islands, and rural airports.

In FY2016 the LFF supported patient care services provided by LifeFlight of Maine through the purchase and donation of: a) specialized medical equipment used in resuscitation and care of critically ill and injured patients including the acquisition of invasive patient monitoring systems, point of care laboratory equipment, intravenous medication pumps, ventilators, a newborn infant transport system, cardiac monitor and defibrillators, and video laryngoscopes, b) the acquisition, upgraded avionics, and the installation of the medical interior and patient support systems for a KingAir 200 fixed wing aircraft, c) the initial deposits and completion payments for a new helicopter, d) the conversion, remodeling and systems upgrade of a new hangar and communication facility at the Bangor International Airport.
