At least one grant will be awarded to a first-time attendee, if applicable. Winners are expected to submit an expense report within one month after the close of the meeting. The Dena Epstein Award for Archival and Library Research in American Music was created to support research in archives or libraries internationally on any aspect of American music. There are no restrictions as to an applicant's age, nationality, profession, or institutional affiliation. The Gerboth Award is made to members of MLA who are in the first five years of their professional library careers, to assist research-in-progress in music or music librarianship. The Duckles Award for Publications is an annual award for the best book-length bibliography or other research tool in music, named in honor of Vincent H. Duckles in 1985. The O'Meara Award for Publications is an annual award for the best review published in Notes. The Lenore F. Coral IAML Travel Grant is intended to help support travel and conference fees to attend an annual IAML meeting. The grant is usually offered every other year, on even numbered years. The grant is open to all MLA members who are also members of IAML, with priority given to members attending their first or second IAML conference who have not received this award in a previous year.
