Prepares and distributes policy analysis for issues of concern. The organization advocates on behalf of senior citizens through the Center for Senior Services. Senior Services and Senior Housing. Actions by the Center for Senior Services, through a network of 37 sponsored apartment projects, provides high quality HUD subsidized housing to some 7,000 low income seniors on a non sectarian basis, provides services to improve the management and administration of the network, and works with B'nai B'rith groups to prepare applications to HUD for additional properties. Also investigates the affordable senior housing options. The Center for Senior Services also provides ongoing workshop on a variety of topics of interest to older persons that include, but are not limited to aging in place, Medicare, social security, transportation, stem cell research, and health care reform.

Volunteers in the U.S. are aided by a network of staff who provide assistance to volunteers located in 17 B'nai B'rith Regions
