THE GIFT PROCESSING CENTER RECEIVES AND PROCESSES OVER 200,000 TRANSACTIONS ANNUALLY FOR THE GREATER UNIVERSITY COMMUNITY. THE UVA FUND OFFERS FINANCIAL AND ENDOWMENT MANAGEMENT SERVICES TO UNIVERSITY RELATED FOUNDATIONS, STUDENT ORGANIZATIONS, ALUMNI CLUBS AND CHAPTERS, AND HUNDREDS OF ENDOWMENTS, SCHOLARSHIPS AND RESTRICTED ACCOUNTS FOR THE UNIVERSITY COMMUNITY. THE ASSOCIATION ALSO MANAGES AND ADMINISTERS THE JEFFERSON TRUST PROGRAM, WHICH PROVIDES ANNUAL GRANTS TO PROJECTS THAT ENHANCE THE UNIVERSITY AS A PREEMINENT GLOBAL INSTITUTION OF HIGHER LEARNING. FEES ARE GENERATED BY THESE SERVICES ON A COST RECOVERY BASIS.
