CHILDREN'S EDUCATIONAL SERVICES - CHILDREN'S EDUCATIONAL SERVICES, IS COMPRISED OF DOOLEY SCHOOL AT ST JOSEPH'S VILLA (INCLUDING THE ELEMENTARY SCHOOL PROGRAM), DOOLEY CENTER FOR ALTERNATIVE EDUCATION, BROOK ROAD ACADEMY, AND CAREER AND TRANSITION SERVICES (CATS) THE 2015-2016 SCHOOL YEAR WAS A VERY PRODUCTIVE YEAR WITH DOOLEY SCHOOL AT ST JOSEPH'S VILLA SERVING 84 STUDENTS THROUGHOUT THE YEAR THIS WAS AN INCREASE OF 78% OVER THE 47 STUDENTS WE SERVED IN THE 2014-2015 SCHOOL YEAR DOOLEY SCHOOL ADDED A DOOLEY PREP HIGH SCHOOL CLASS (WE NOW HAVE 3 HIGH SCHOOL CLASSES AND ONE MIDDLE SCHOOL CLASS), SERVING STUDENTS WITH AUTISM, INTELLECTUAL DISABILITIES, AND EMOTIONAL DISABILITIES WHO REQUIRE A VERY SUPPORTIVE CLASSROOM AND GREATER TRANSITION SERVICES (FUNCTIONAL, PRE-VOCATIONAL) WITH OUR CATS PROGRAM ONE DOOLEY STUDENT GRADUATED AND ALL STUDENTS MADE PROGRESS ON THEIR IEP GOALS DOOLEY CENTER FOR ALTERNATIVE EDUCATION (STUDENTS WHO ARE LONG TERM SUSPENDED OR EXPELLED FROM PUBLIC SCHOOL) HAD A POSITIVE YEAR SERVING A TOTAL OF 37 STUDENTS WITH 84% OF THE STUDENTS IMPROVING OR SUSTAINING GRADES WITH 67% PASSING SOL TESTS THIRTEEN STUDENTS WERE ABLE TO TRANSITION BACK TO PUBLIC SCHOOL AT THE END OF THE YEAR DUE TO BEHAVIORAL IMPROVEMENT BROOK ROAD ACADEMY, A COLLEGE PREPARATORY SCHOOL, SERVED 32 STUDENTS UNDER THE DIRECTION OF A NEW HEAD OF ACADEMY EIGHTY-ONE PERCENT OF THE STUDENTS IMPROVED OR SUSTAINED GRADES AND 6 GRADUATED FROM THE PROGRAM AND ALL BUT ONE STUDENT WENT ON TO POST SECONDARY EDUCATION ONE STUDENT WENT INTO HIS FAMILIES' BUSINESS AS IN THE PAST, BEHAVIOR WAS NOT AN ISSUE FOR THE MAJORITY OF THE STUDENTS CATS SERVED 109 CLIENTS FROM THE EDUCATION SERVICES AND SARAH DOOLEY CENTER FOR AUTISM CATS WORKED WITH 16 DOOLEY ELEMENTARY STUDENTS IN ADDITION, CATS CONDUCTED 4 WORKSHOPS WITH CLIENTS FROM FLAGLER SERVICES CATS PRODUCED OVER 18,000 SNACKS FOR THE YEAR 4 CATS PARTICIPANTS GOT INTO COLLEGE OR POST-SECONDARY TRAINING AND 8 STUDENTS GOT AND KEPT JOBS VOLUNTEERS COMMITTED OVER 250 HOURS OF COMMUNITY SERVICE IN THE GARDEN OR THROUGH A SPEAKING ENGAGEMENT WITH OUR STUDENTS VCU STUDENT MENTORS PROVIDED OVER 800 HOURS OF MENTORING TO THE STUDENTS IN EDUCATION SERVICES CATS PARTICIPANTS AND STAFF PRODUCED NEARLY 7 TONS OF SHREDDING CATS ALSO CREATED 150 IDENTIFICATION BADGES CATS CONTINUED IT'S PARTNERSHIP WITH VCU, UNIVERSITY OF RICHMOND, LEWIS GINTER BOTANICAL GARDENS, RICHMOND ANIMAL CARE AND CONTROL, RESTORE WITH HABITAT FOR HUMANITY AND A HOST OF OTHER GUEST SPEAKERS
