ASSISTANT (CNA) PROGRAM WAS APPROVED BY MEDICARE AS AN ALLIED HEALTH EDUCATION PROGRAM IN ORDER TO QUALIFY AS A MEDICARE-APPROVED PROGRAM, A PROVIDER MUST INCUR THE COSTS ASSOCIATED WITH BOTH THE
