The Neighborhood Stabilization Program (NSP) is a Federal program that began in 2008 and is administered by local jurisdictions through sub-grantees NSP was designed to re-stabilize communities in which the sub-grantees purchase foreclosed properties to be rehabbed and re-sold to income-eligible buyers The organization became an NSP approved sub-grantee in 2009 and has acquired 19 homes through Fiscal Year 2016, 17 properties have been sold, 1 is under a lease-to-purchase contract, the final is also under contract More than half the buyers have had incomes less than 50% AMI The 19 homes have all been purchased in Prnce William County, VA These NSP homes are provding permanent homes through the NSP homeownership opportunities to 58 persons
