THE ORGANIZATION CONTRACTS WITH PHARMBLUE LLC IN ORDER TO OPERATE AS A FULL SERVICE PHARMACY TO ITS CLIENTS BEGINNING MAY 2013. THE PROGRAM ALLOWS OUR MEDICAL CASE MANAGERS TO MORE CLOSELY MONITOR MEDICATION ADHERENCE TO HIV CARE.
