(SEE SCHEDULE O FOR CONTINUATION) WE PROVIDED 800 NEW BLANKETS, 2,220 NEW ADULT AND YOUTH COATS, 3,825 SETS OF HATS, GLOVES AND SCARVES, 20 HYGIENE KITS AND 2,350 BACKPACKS FILLED WITH SCHOOL SUPPLIES FOR ELEMENTARY AND JUNIOR HIGH STUDENTS, 21,900 DIAPERS, 350 PAIRS OF NEW SHOES, 720 BOXES OF DRY FOOD, 680 BOXES OF LAUNDRY DETERGENT, AND 1,926 BARS OF SOAP. FOR THE HOLIDAYS, 6,815 TURKEYS WERE PROVIDED FOR THANKSGIVING AND CHRISTMAS. MORE THAN 21,000 INDIVIDUALS WERE SERVED SAFE PLACES PROGRAM - CHRISTIAN RELIEF SERVICES RUNS AN IMPORTANT PROGRAM TO PROVIDE TRANSITIONAL HOUSING AND SUPPORT SERVICES TO WOMEN WITH CHILDREN WHO ARE VICTIMS OF DOMESTIC VIOLENCE. THE PROGRAM, CALLED SAFE PLACES, OPERATES ONLY IN FAIRFAX COUNTY, VIRGINIA. DOMESTIC VIOLENCE SHELTERS IN FAIRFAX COUNTY GENERALLY ONLY ALLOW A PERSON TO STAY FOR UP TO 30 DAYS AFTER FLEEING THEIR ABUSER. THAT IS NOWHERE NEAR ENOUGH TIME FOR A TRAUMATIZED DOMESTIC VIOLENCE VICTIM WHO FOUND THE COURAGE TO LEAVE HER HOME TO RESTART HER LIFE ANEW. THROUGH THE PROGRAM, WOMEN WHO FLEE TO A FAIRFAX COUNTY SHELTER ARE REFERRED TO SAFE PLACES WHERE THEY ARE ABLE TO SECURE AFFORDABLE HOUSING OWNED AND MANAGED BY CHRISTIAN RELIEF SERVICES, PAYING ONLY 30 PERCENT OF THEIR GROSS WAGES, FOR UP TO TWO YEARS. THE CLIENT IS REQUIRED TO BE EMPLOYED, IS OFFERED SUPPORT IN FURTHERING THEIR EDUCATION AND ASSISTANCE IN LIFE SKILLS, SUCH AS BUDGETING AND PARENTING. IN FY2016, SAFE PLACES PROVIDED A TOTAL OF 8,623 SAFE NIGHTS TO 30 FAIRFAX COUNTY FAMILIES. TRANSITIONAL HOUSING PROVIDED UP TO 24 MONTHS WITH CASE MANAGEMENT AND SUPPORTIVE SERVICES FOR ADULTS WITH MENTAL AND PHYSICAL DISABILITIES. IN 35 UNITS UNDER THE HOUSING PROGRAM IN NORTHERN VIRGINIA DIGITAL DIVIDE - CHRISTIAN RELIEF SERVICES TOOK UP THE CHALLENGE TO HELP BRIDGE THE 'DIGITAL DIVIDE' IN FAIRFAX COUNTY PUBLIC SCHOOLS ALONG THE RICHMOND HIGHWAY CORRIDOR BY PROVIDING NEW LAPTOP COMPUTERS TO ALL FOURTH, FIFTH, AND SIXTH GRADE STUDENTS AT BUCKNELL ELEMENTARY SCHOOL WHICH HAS A FREE OR REDUCED MEAL POPULATION IN EXCESS OF 80 PERCENT. THE PILOT PROGRAM IS FOR ONE YEAR WHICH CHRISTIAN RELIEF SERVICES HOPES TO REPLICATE IN SIMILAR SCHOOLS IN THE DISTRICT WITH HELP FROM LOCAL BUSINESSES AND THE FAITH COMMUNITY. 120 STUDENTS RECEIVED A LAPTOP.
