Homestretch also provided kitchen furnishings, household furniture and supplies, on a pass-through basis, as items are donated by the community at large. Homestretch, Inc. continues to serve an average of 66 families at any point in time, using a combination of housing models including transitional housing, permanent supportive housing, transitioning-in-place, and affordable housing for low-income families.

The intake process occurs as families graduate and additional housing is available. These are not grants, but assistance. At any point in time, there are usually 66 families and 200 individuals, most of whom are children, residing in Homestretch units. While services are offered for all families, not all families are required to access the services. Some, like those in "transitioning-in-place or affordable housing, may access services on a voluntary basis.
