The Richmond Ballet is one of Virginia's finest arts and education institutions and has gained national and international acclaim as a premier dance organization. This year, over 30,000 people in and around the Richmond, VA area were entertained by four repertory performances as well as full length productions of the "Nutcracker" and "Romeo and Juliet". The ballet also performed in Buffalo, NY and completed tours to various Virginia localities.

The School of Richmond Ballet provides dance classes (ballet, jazz, modern, theater dance, and character) for over 700 students age 3 to adult 7 days a week. The school also provides advanced training for qualified students who perform with the Ballet's professional dance troupe.

In its 22nd year, this educational outreach program provides year-long in-school classes teaching fourth graders discipline, dedication and self-awareness through dance. In the cities of Richmond and Charlottesville and surrounding counties, over 25 schools participated in the program. A 2-week residency was also conducted in Israel. The students perform on stage in a themed production at the end of each school year.
