## **The Windsor Foundation Trust Distribution Board U/W Quincy Cole**

### **GENERAL POLICIES AND APPLICATION GUIDELINES**

The Windsor Foundation Trust was established in 1969 under the Will of Quincy Cole for the purpose of making distributions for religious, scientific, educational, artistic, historical and/or charitable endeavors in the metropolitan area of Richmond, Virginia. The Trust is an organization described in Internal Revenue Code section 501(c)(3) and is classified as a private foundation for federal tax purposes.

#### **General Policy Guidelines**

Grants are made to institutions or organizations which qualify as public charities under Internal Revenue Code section 501(c)(3) and 509(a)(1), (2), or (3) (other than organizations classified as Type III supporting organizations that are not functionally integrated).and that operate exclusively for charitable, scientific, literary, or educational purposes, so long as attempts to influence legislation or to support candidates for public office do not form part of their activities. Because of burdensome expenditure responsibility rules, grants are not normally made to organizations classified as private foundations, private operating foundations, or Type III supporting organizations that are not functionally integrated.

Although the Distribution Board has not established inflexible limitations upon the purposes for which it will award grants, in general, requests for endowment funds will be subordinate to grants for other purposes. Requests for general operating expenses are seldom awarded. Preference is given to specific, well-defined projects and programs whose results can be evaluated. Contributions are not made to periodic campaigns for funds by national or community organizations. Grants are not made to individuals.

A grant request from an organization that has previously received a grant from the Trust will not be considered unless submitted three or more years from the date of the last payment of the previous grant.

#### **Application Guidelines**

Although the Trust does not require proposals to follow a specific format, in general, each organization applying for a grant is expected to submit five (5) copies of a written proposal. To the extent applicable, the written proposal should include the following information:

- A covering letter from an official of the organization stating that the organization has formally approved the proposed program or project.
- A description of the organization, including its history and purpose.
- Names and affiliations of the organization's trustees, directors, advisors, and principal staff
- A concise description of the project or activity proposed, including the specific purposes for which the grant is requested, benefits to be provided, and the needs to be met, as well as a time frame for the use of the funds.

- An overview of total costs, including the specific amount requested, the amount raised to date, plans for procuring the remainder (if any), and a timeframe for raising funds. .
- Plans for evaluation of the project's results and for sustaining the project after grant funds expire.
- A copy of the organization's IRS determination letter or other appropriate evidence regarding the organization's status as a section 501(c)(3) organization and its classification as a public charity (other than a Type III supporting organization that is not functionally integrated).
- A financial statement for the current and previous year showing the major sources of organizational support and endowment, if any.

#### Application Deadlines and Review

Applications will be accepted at any time. They will be reviewed by the Distribution Board and will be evaluated at the meetings held in the spring and fall of each year, generally in May and November. The deadline for receipt of proposals for the spring meeting is April 1, and for the fall meeting is October 1. Applicants will be notified in writing of the decision of the Distribution Board after the meeting at which their proposal has been considered. It is important for applicants to understand that it is only the Distribution Board as a group that makes grant decisions and that the volume of applications and subjective considerations involved preclude the Trust from critiquing unsuccessful applications. Accordingly, inquiries of this nature are discouraged.

#### Payment

For approved grants, the funds will be forwarded to the recipient organization as stated in the award letter.
