DURING THE 2016 FISCAL YEAR, CHILDREN'S HOME SOCIETY OF NORTH CAROLINA PROVIDED A BROAD RANGE OF OUTCOMES-FOCUSED PREVENTION, FAMILY SUPPORT AND CHILD WELFARE SERVICES TO MORE THAN 20,000 CHILDREN AND FAMILIES. SEE SCHEDULE O FOR CONTINUATION OF ACCOMPLISHMENTS PROMOTING THE RIGHT OF EVERY CHILD TO A PERMANENT, SAFE, AND LOVING HOME. CHS PROVIDED TEMPORARY FOSTER CARE FOR 662 CHILDREN AND FACILITATED ADOPTIONS FOR 146 CHILDREN. THESE EFFORTS INCLUDED THE RECRUITMENT OF ADOPTIVE PARENTS, PRE-PLACEMENT ASSESSMENTS, TRAINING AND PREPARATION OF FAMILIES, AND RELATED ADOPTION SERVICES AND COUNSELING PROVIDED TO 2,102 INDIVIDUALS. WHERE APPROPRIATE, CHS WORKS TO CONNECT CHILDREN WITH THEIR BIOLOGICAL AND FICTIVE KIN UTILIZING OUR FAMILY FINDING PROGRAM, WHICH SERVED 369 YOUTH. CHS HELPED ENSURE PLACEMENT STABILITY BY PROVIDING 135 FAMILIES AND 200 CHILDREN WITH CLINICAL SUPPORT SERVICES. OUR COMMITMENT INCLUDES LIFE-LONG SUPPORT FOR ADOPTEEES AND FAMILIES. 1,305 ADOPTEEES, ADOPTIVE PARENTS, AND BIRTH PARENTS WERE PROVIDED WITH POST ADOPTION SERVICES. CHS PROVIDED INTENSIVE FAMILY PRESERVATION SERVICES FOR 217 FAMILIES AND 549 YOUTH TO IMPROVE FAMILY FUNCTIONING, WITH THE GOAL OF ENABLING CHILDREN TO SAFELY REMAIN IN THEIR HOMES. OUR PREVENTION WORK INCLUDED PARENT EDUCATION PROGRAMS FOR 4,699 PARENTS AND CAREGIVERS. THESE PROGRAMS FOCUS ON BUILDING STRONG, HEALTHY RELATIONSHIPS BETWEEN PARENTS AND CHILDREN. IN ADDITION, OUR YOUTH EDUCATION PROGRAMS SERVED 7,268 ADOLESCENTS THROUGH LIFE SKILL DEVELOPMENT, TEEN PREGNANCY PREVENTION, AND SUBSTANCE ABUSE PREVENTION PROGRAMS. CHS PROVIDED PROFESSIONAL TRAINING SERVICES TO 2,738 PROFESSIONALS IN THE CHILD WELFARE FIELD TO INCREASE THEIR KNOWLEDGE AND SKILLS.
