Senior Aides program has been affiliated with the United Way of the Cape Fear Area for more than 30 years. This Federally funded program trains and prepares low-income senior workers (55 and older) for entry or re-entry into the workforce.

4b (Code) (Expenses \$ **216,802** including grants of \$ **21,649**) (Revenue \$)
Community Impact is the primary focus of UWCFA. UWCFA engages community experts in determining the most critical local issues and challenges and then implements a vetting process that allows local volunteers to determine the most effective and efficient programs in which donor gifts are invested, resulting in long-term, positive changes to the lives of people in the Cape Fear Area. This process assures the greatest return on donor investments because of the ability of nonprofit partners to leverage these investments with other resources, and it guarantees measureable outcomes that are reported on a quarterly basis. As a result, over 130,000 lives are changed for the better EVERY YEAR.

The Marketing and Communications program supports key functions within UWCFA's structure including: community impact; resource development; Senior Aides; 10 Year Plan to End Chronic Homelessness; and other critical initiatives identified by the community. UWCFA Marketing works to build awareness and visibility of the brand as a way to continually educate and inform the general public about what UWCFA does and how it is intertwined in the community. UWCFA uses visual and written communications and a variety of different advertising vehicles including: print, digital and social media avenues.
