THE REFUGEE AND IMMIGRATION SERVICES PROGRAMS PROVIDE RESETTLEMENT AND IMMIGRATION SERVICES. THE RRO PROGRAM ADMINISTERS THE RECEPTION AND PLACEMENT (R&P) PROGRAM THROUGH ITS AFFILIATION WITH THE US CONFERENCE OF CATHOLIC BISHOPS/MIGRATION AND REFUGEE SERVICES (USCCB/MRS). THE CCDOC/RRO HAS RESETTLED MORE THAN 15,000 REFUGEES OF TWENTY-SEVEN (27) DIFFERENT NATIONALITIES SINCE THE BEGINNING OF THE PROGRAM IN 1975. THE IMMIGRATION SERVICES PROGRAM IS RECOGNIZED BY THE BOARD OF IMMIGRATION APPEALS. OUR IMMIGRATION PROGRAM PROVIDED 1,042 SERVICES TO 553 CLIENTS BETWEEN THREE OFFICE LOCATIONS DURING THE 2015-16 FISCAL YEAR.
