THE NUMBER OF CLIENTS SEEKING TRAUMA FOCUSED AND VICTIM CENTERED SERVICES TOTALED 235 THIS YEAR. OUR CLIENTELE REMAINS PREDOMINANTLY CHILDREN WHILE WE SEE A CONTINUING RISE IN NUMBERS AGAIN THIS YEAR WITH THE ADOLESCENTS AND ADULT POPULATION.

OUR OUTREACH SERVICES AND STAFF HAVE REACHED 1,129 COMMUNITY, ORGANIZATIONAL AND CIVIC MEMBERS. THESE INCLUDED DARKNESS TO LIGHT TRAININGS, AWARENESS AND EDUCATIONAL PRESENTATIONS FOR A TOTAL OF 51 FOR THIS YEAR.

PROMISE PLACE HAS ALSO INCREASED ITS NUMBERS OF GROUPS FOR ADULTS, ADOLESCENTS AND CHILDREN OFF ERRING TRAUMA FOCUSED THERAPEUTIC GROUPS
