FISCAL 2016 WAS A RECORD YEAR FOR HABITAT CHARLOTTE, WITH PLENTY OF GAINS TO REPORT. THE NUMBER OF FAMILIES SERVED BY THE AFFILIATE GREW AN IMPRESSIVE 11%, FROM 111 IN FY15 TO 123 IN FY16. CONTRIBUTED INCOME AND PRIVATE GRANTS WERE UP 7% OVER PRIOR YEAR, CONSTRUCTION GIFTS-IN-KIND NOTCHED UP 4%, AND THE OVERALL NUMBER OF FINANCIAL DONORS TO HABITAT CHARLOTTE INCREASED BY 8%. WELCOME GAINS, ALL PLEASE SEE SCHEDULE O FOR A CONTINUATION OF PROGRAM SERVICE ACCOMPLISHMENTS. THIS WAS A REMARKABLY BUSY YEAR, PARTICULARLY MARCH THROUGH JUNE BECAUSE 2016 REPRESENTED THE 25TH ANNIVERSARY OF WOMEN BUILD--AN INTERNATIONALLY ADOPTED BUILD STARTED BY HABITAT CHARLOTTE--THE AFFILIATE HOSTED A PUBLIC SYMPOSIUM ON AFFORDABLE HOUSING IN MARCH THAT DREW AN AUDIENCE OF 300, AND CELEBRATED IN MAY WITH 500+ SUPPORTERS AT ITS FIRST-EVER BLUE JEAN BASH FUNDRAISER/GALA. THAT SAME MONTH, HABITAT CHARLOTTE PLAYED HOST TO 180 AMERICORPS MEMBERS FROM AROUND THE COUNTRY FOR A WEEK-LONG BUILD-A-THON BLITZ SUPPORT FOR OUR SISTER AFFILIATE IN EL SALVADOR--THE RECIPIENT OF HABITAT CHARLOTTE'S ANNUAL TITHE TO HABITAT FOR HUMANITY INTERNATIONAL IN ATLANTA, GEORGIA -- GREW BY 5.6% IN FY16, BRINGING THE CUMULATIVE TITHE TO \$3.99 MILLION. SINCE 1993 THIS SUPPORT HAS PROVIDED SAFE, DECENT HOUSING TO MORE THAN 1,400 FAMILIES IN EL SALVADOR AND DISTINGUISHES HABITAT CHARLOTTE AS THE HIGHEST-TITHING AFFILIATE IN ALL OF HABITAT FOR HUMANITY INTERNATIONAL. FINALLY, AFTER MONTHS OF PLANNING, THE AFFILIATE OPENED ITS THIRD RESTORE IN JUNE. OF ALL MONETARY DONATION SOURCES SUPPORTING HABITAT CHARLOTTE'S AFFORDABLE HOUSING PROGRAMS, RESTORE PROFITS REPRESENT THE LARGEST INDIVIDUAL SOURCE. RESTORE REVENUES REMAINED STRONG THROUGHOUT FY16, AND NET PROFIT FROM THE TWO EXISTING STORES CLIMBED 4.9% YEAR OVER YEAR. IN ADDITION TO FORECASTS ASSOCIATED WITH THE THIRD STORE, A STRONG INDICATOR THAT PORTENDS WELL FOR RETAIL OPERATIONS IS THE GROWTH EXPERIENCED IN DONATION PICKUPS, WHICH JUMPED NEARLY 20%.
