A GRASSROOTS RESPONSE TO FOOD WASTE AT THE RETAIL AND WHOLESALE LEVEL, THE FOOD RECOVERY PROGRAM COLLECTS HEALTHY PERISHABLE FOOD FROM DONORS AND DISTRIBUTES THE FOOD TO AREA HUNGER RELIEF PROGRAMS ON REFRIGERATED TRUCKS. IFFS RECOVERED OVER 6 MILLION POUNDS OF FOOD IN 2015, 42% OF WHICH WAS FRESH PRODUCE, AND DISTRIBUTED IT THROUGH 202 COMMUNITY CENTERS IN 7 COUNTIES. MONTHLY AVERAGES OF PEOPLE SERVED INCLUDE: 6,986 INDIVIDUALS ACCESSING MOBILE MARKET DISTRIBUTIONS, 1,647 SENIORS RECEIVING GROCERY BAGS AT THEIR DOORS, AND 2,050 BACKPACKS DISTRIBUTED TO CHILDREN. 38,321 PEOPLE EACH MONTH RECEIVED FOOD FROM PANTRIES, SOUP KITCHENS & SHELTERS WHERE WE DELIVER FOOD. THE FARM IS USED AS A TEACHING TOOL FOR AGRICULTURAL PRODUCTION, AND AS A MEANS FOR IFFS TO INCREASE FRESH FOOD PRODUCTION FOR DISTRIBUTION BACK INTO THE COMMUNITY. IFFS COMBINED NUTRITION EDUCATION WITH THEIR MOBILE MARKETS. IFFS HELD 59 SIX WEEK COOKING MATTERS CLASSES WITH 624 PARTICIPANTS THAT TEACH COOKING AND HEALTHY EATING HABITS TO LOW-INCOME CHILDREN, TEENS, ADULTS AND FAMILIES.
