The North Carolina Pre-Kindergarten (NC Pre-K) program provides high-quality educational experiences to enhance school readiness for eligible four year old children. Risk factors and eligibility is determined by the State of North Carolina. NC Pre-K providers utilize licensed teachers and standardized curriculum in the classroom over a ten month program preparing children for Kindergarten. During the 2015-2016 fiscal year the RAPC provided funding to serve over 550 children in 49 classrooms by contracting with local school districts, Head Start centers, and private early care and education centers.

Smart Start (North Carolina's innovative early childhood program) related initiatives. Through State and private funding sources, the RAPC serves the children and families of western North Carolina by providing both in-house services and partnering with health departments, family resources centers, mental health professionals, local library systems, physicians offices, and other nonprofit organizations to provide early care and education programs that provide on-site technical assistance for childcare centers, professional development and incentives for early care educators, regional literacy programming, early education subsidies for eligible families, and parent education. Total families served through Parents As Teachers program - 283, Early Care and Education Centers served through Child Care Health Consultants (CCHC) - 79 and the Reading Rover - 24, Individual educators served through CCHCs, Quality Enhancement and Social Emotional training - 1,073, Children ages 0-5 served through direct in-house and contracted Smart Start service programs - 5,250

Family Support Network of Region A (FSNRA) - As an affiliate of the Family Support Network of North Carolina, the FSNRA provides support for families of children with special needs.
