Quality Early Care and Education - Based on research showing the long-term impact of early education, the Partnership focuses on strategies that improve the quality of child care, increase access to child care for low income families and support early childhood teacher education. The Partnership also offers NC Pre-K, a quality pre-kindergarten classroom program for 480 at risk four year olds. The Partnership manages two federal grants to provide full comprehensive Early Head Start services to 172 infants and toddlers (0-3) via two program models, Center-based and Home-based services.

4b (Code: HIFS) (Expenses \$ 877,622 including grants of \$ 863,359) (Revenue \$)

Health, Early Intervention and Family Support - Physical and developmental health is critical to a child being in the best condition to learn. In response to this need, Durham's Partnership for Children invests in a variety of programs that offer support for parents and child health and developmental interventions. The Partnership funds a continuum of Family Support programming in Durham County including linking families to community resources, hospital visits to new parents, curriculum-based parent education and literacy series, consultation and training on children with challenging behaviors, and an intensive home visiting program.

4c (Code: CDCB) (Expenses \$ 439,609 including grants of \$ 20,079) (Revenue \$)

Community Development and Capacity Building - The Partnership funds two strategies, Community Awareness and Education and Program Coordination and Evaluation, which focus on Community Development and Capacity Building. The Community Awareness and Education program creates educational materials; develops, manages, and supports public relations activities; and coordinates events in order to build awareness of issues affecting young children and their families. The Program Coordination and Evaluation program conducts technical assistance, monitoring, evaluating, program development, data collection and analysis, and needs assessments in order to achieve program excellence and effectiveness. One community based initiative also fall under Program Coordination Transition to Kindergarten. The Durham Touchpoints Collaborative continues as the hub of a second community based initiative: Early Childhood Training Institute.

The Partnership monitors each Smart Start funded program on an annual basis through program observation, site visits, completion of a Direct Service Provider Monitoring Tool and review of program and fiscal reporting throughout the year. The annual programmatic and fiscal monitoring site visit includes a review of the compliance with the Contract Activity Description, documentation of evaluation, compliance with communication standards, compliance with grants management, financial status reports, cash receipts, cash disbursements, competitive bidding, cash and in-kind contributions and property and equipment. Based on this review and completion of a monitoring tool, a report is completed and provided to the funded program. Follow-up technical assistance and development of a corrective action plan will occur if necessary. NC Pre-Kindergarten Monitoring: The Partnership conducts monitoring as part of the NC Pre-Kindergarten Program in Durham County. Monitoring activities for participating NC Pre-Kindergarten sites are conducted throughout the year to ensure that program requirements are met. Pre-K sites are required to complete an annual Site Monitoring Tool that is designed to address the components of the program to meet compliance areas at the site and classroom level. Sites submit the completed tools to the local contractor's office. The Partnership's NC Pre-K department reviews the tools and conducts a site visit to ensure that all information is correct and accurate and in compliance with State requirements. Start - Monitoring: The Partnership, in compliance with Federal standards and administrative requirements, provides ongoing monitoring of its operations as well as those of its contracted delegate agency. It is the policy of the Grantee that all programmatic, fiscal, and management areas of the Early Head Start program are regularly reviewed and that appropriate and

timely follow-up is provided to ensure correction of non compliance issues. A full monitoring review of the delegate agency is conducted by program and fiscal staff on an annual basis

Background about the Partnership

Since 1995, Durham's Partnership for Children (DPfC) has created a comprehensive early childhood system that supports collaborative service delivery and planning. DPfC's mission is "To ensure every child in Durham enters school ready to succeed, we lead community strategies for children birth to 5 and their families that promote healthy development and learning and enhance access to high quality care."

The Partnership has formed strategic alliances within various sectors including government, business, medical, faith and education to integrate evidence based practices and measurable results.

DPfC is one of 75 local Partnerships in North Carolina. It is the leader charged with implementing North Carolina's Smart Start Initiative, NC Pre-Kindergarten Programs for Durham County, and Durham Early Head Start. In FY 15-16, DPfC funded 10 Smart Start programs 34 NC Pre-Kindergarten classrooms, and Early Head programs with both center based and home based components.

Additionally, DPfC leads the Durham Touchpoints Collaborative, which is the hub of the Early Childhood Training Institute, (ECTI), and the Transition to Kindergarten Initiative. Touchpoints trains providers from across disciplines to provide a strengths-based common language for working with families during times of vulnerability. The ECTI also provides training in Family Connections, Racial Equity, and Toxic Stress and poverty. Transition to Kindergarten engages a variety of community stakeholders to plan and implement transition activities for rising kindergarteners and families throughout Durham.
