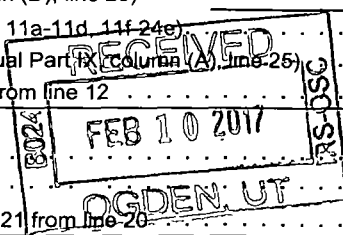

The Foundation administers the programmatic deliverables for the NBCC Minority Fellowship Program, through which twenty-three doctoral students in counseling received \$20,000 education awards, up to 40 master's mental health counseling students received \$5000 and up to 30 master's substance abuse counseling students receive up to \$11,000. The Foundation provides training assistance, mentors and networking opportunities to enable them to successfully complete their programs, and take leadership roles in reducing the disparities in mental health care for minority populations.

The Foundation supports efforts to build the capacity of communities to provide mental health care through 2 primary initiatives: implementation of the NBCC Mental Health Facilitator program, and training and technical assistance in implementing counseling services. To date, the NBCC Foundation has supported the implementation of the Mental Health Facilitator program in several countries, and ongoing to support to the programs in Bhutan, Malawi, Mexico, Tanzania, and Uganda; has provided counseling education materials free of charge to Bhutan, Malawi, Nigeria, Portugal, and Romania; and training and technical assistance in DeKalb County, GA, Jonesboro, GA, and Jacksonville, FL.

Annually, the Foundation awards scholarships to individuals who are pursuing careers in professional counseling, and who commit to serving those in rural and/or minority communities for 2 years post graduation. To date, the NBCC Foundation has provided scholarships to counseling students committed to serving rural and military communities in 38 states.
