CCCD's mission is to advance the understanding of craft by encouraging and supporting research, critical dialogue, and professional development in the United States.
Pt II Ln 17a	CCCD has forged wide-ranging partnerships and is now associated with groundbreaking work in the scholarship of American craft. In addition, each year CCCD administers over a quarter of a million dollars in grants to craft artists and scholars.
Pt II Ln 17a	The 18-member Board of Directors is comprised of volunteers from a variety of fields (legal, business, academic, nonprofit, arts) who serve with a broad representation of interests. Five of the 18 members are out of state and three reside beyond the immediate region. Our major donors do not serve on our board.
Pt II Ln 17a	On July 22, 1998, the nonprofit support organization received 501c3 authorization for the purpose of soliciting funds for programs and operations. For the first 16 years, CCCD's support was consistently above 33 1/3% with support coming from unrelated visitors, donors, university partners, and foundations.
Pt II Ln 17a	In August 2013, a generous gift from the Windgate Charitable Foundation allowed CCCD to purchase a historic facility that is in the process of being transformed into a hub for the creative sector in downtown Asheville, NC. Budget cuts to the UNC system incited transition for the organization and put into question CCCD's location, as well as funding for staffing and operations. On October 1, 2013, the nonprofit 501c3 assumed full authority over CCCD's mission and stabilized with the support of individual donors and foundations.
Pt II Ln 17a	During January 2014, CCCD relocated from Hendersonville, NC to its facility in downtown Asheville, NC. The site has provided a home base to continue its free, public programs in a 2,500 square foot gallery. CCCD's annual visitorship has grown from 650 reported in FY 2012 to 8,372 during 2015.
Pt II Ln 17a	CCCD raises funds for programs that are offered to the general public through free exhibitions, lectures, workshops, conferences, and residences. CCCD's current support comes from grants (local, state, federal, and foundation), individual donations, and leases from owning property. CCCD has developed strong relationships with the surrounding educational institutions including Warren Wilson College, UNC Asheville, Haywood Community College, Western Carolina University, AB Tech, and Appalachian State University. This includes an active docent internship program that integrates work experience with gallery education for up to three interns per semester.
Pt II Ln 17a	CCCD solicits support from the general public and community a minimum of once per year during its annual appeal. We receive donations in amounts typically in the \$50 - \$1,000 range and we apply for a minimum of 5 foundation grants per year. During December 2014, the Board of Directors hired a fundraising consultant to put together an initial plan for 2015-2017. In November 2015, CCCD contracted with a Development Advisor to further implement this fundraising plan that continues to grow a national base of unrelated donors.
Pt II Ln 17a	CCCD maintains a strong reputation as both a significant national and local resource. CCCD has 3,593 followers on Facebook, 1,168 followers on Twitter, 1,708 followers on Instagram and 5,009 subscribers to our Enews. We include national and local experts from museums and universities, artists, and community partners in our programs and presentations. Programs are well attended, averaging 80 attendees per event. In 2015, CCCD organized 39 programs and events. All lectures are also recorded and placed on our website to reach a broader, nonlocal audience.
Pt II Ln 17a	CCCD has identified three core profiles for its audience: cultural tourists, regional college students and teachers, and creative professionals. CCCD actively partners with local organizations both inside and outside of the creative sector in an effort to reach new enthusiasts. Over the last two years partners have included the Textile Study Group, Society of North American Goldsmiths, YWCA's Stand Against Racism campaign, Date My City, Swannanoa Valley Museum, Asheville History Center, Museum of Arts and Design (New York), and the Crafts Study Centre (Farnham, UK). CCCD has also successfully developed relationships with city officials, to include Asheville Mayor Esther Manheimer, Vice Mayor Gwen Wisler, and Senator Terry Van Duyn.
