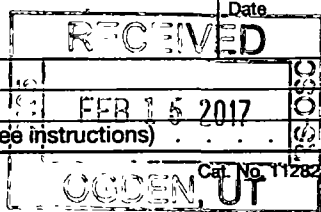

**Public Performances - Musiqa performed two concerts at the MATCH facility and an additional concert at the Hobby Center, Houston, Texas. Each concert included at least one world premiere work by the Musiqa composers and visiting artists from around the United States. Additionally, three free concerts were performed with the Contemporary Arts Museum of Houston in conjunction with art exhibits. In addition, Musiqa provided free outside public park performances available to all the Houston community and performances at Hobby airport to greet the traveling public to the Houston area.**

**Educational Performances -Free outreach programs that were performed for approximately 6000 public school children at Zilka Hall, Houston, Texas. These students also were instructed and participated in free in-school preparatory workshops to enrich the performance programs. The programs included musical and foreign language instruction, music appreciation and exposure to the cultural arts for at-risk students in the community. Additionally, about 200 students participated in the in-school residency program with Musiqa teaching artists. The curriculum for these residencies was designed in collaboration with the schools as a supplement to the academic curriculum.**
