	Overview Harlem Academy prepares gifted, low-income students to catch up with their higher income peers, succeed at top secondary schools, and make their mark on the world. Students showed academic growth and excellence. In 2016 standardized testing, new students gained an average of 11 points in their first year attending Harlem Academy. Returning students continued to show growth, moving up in rank by 4 percentile points on average. By the end of the year, 72% of students scored in the top two deciles nationwide. Graduates are thriving. Over the past five years, 60% of our graduates have matriculated to independent schools and 31% to selective public and Catholic schools. The average annual scholarship for students attending private schools was \$42,713, with students attending Chapin, Hotchkiss, Lawrenceville, Northfield Mount Hermon, Peddie, Riverdale, and Spence Harlem Academy provided more than \$3 million in scholarships to low-income students. Although every family makes a contribution toward tuition, the amount is set on a sliding scale based on income. Providing full-need scholarships ensures that every student can afford to attend Harlem Academy, regardless of his or her financial circumstances. This vital support is essential to realizing the schools mission, opening the door for gifted, low-income children to earn their way to Americas great educational opportunities. Top rating from GuideStar. Harlem Academy received GuideStars platinum rating for strong management and transparency, highlighting the schools continued commitment to use gifts effectively toward advancing our mission.
