The Fund disbursed \$1,718,288 to the Morehead-Cain Foundation to support the nation's oldest and most prestigious undergraduate merit scholarship program at the University of North Carolina at Chapel Hill. This amount represented 23% of the Foundation's program expenses in fiscal year 2016 and helped provide full-cost scholarships, summer enrichment experiences and other developmental opportunities to 272 of the country's most promising future leaders. The financial support provided by the Morehead-Cain Scholarship Fund is a vital and growing portion of the funds needed to sustain and enhance the Morehead-Cain Scholars Program.
