The Foundation provides direct support to NCA&T State University departments by the management of fund accounts that include restricted, unrestricted, scholarships, endowments and grants. The Foundation managed five grants totaling \$882,085 that were awarded whose scope included STEM Scholarships to Construction Management Students and HUD programs and activities; Computer Systems Technology Minority Male Makeover Program and an IBM Faculty Award for zSystems & Linux Open Source Ecosystem Initiatives. The Foundation awarded \$919,103 from department scholarship funds, \$21,138 work study awards and \$275,000 from the Foundation.

The Foundation provides student housing to support the NCA&T State University's enrollment and retention maintaining a 97% occupancy. The Event Center hosts all student intro orientation to the university events, executive board meetings of the Chancellor and special university-related events. The Event Center is the site for annual departmental hosted conferences such as The NC Consortium for International and Interculture Education (NCIIE), Engineering Week, Small Farmers Week, COACH (Alzheimer's Caregivers Conference), BIFAD (Board for International Food & Agricultural Development), Social Entrepreneur Conference, Institute of Industrial Engineering Regional Conference, Women in Technology and Teach for America. The Event Center creates more visibility for the campus which is a component of the university's Preeminence 2020 Master Plan.
