THE ORGANIZATION ALSO HAS PROGRAMS THAT PROMOTE NORMAL GROWTH AND DEVELOPMENT WHICH PROMOTE THE OPTIMAL GROWTH OF PRESCHOOL CHILDREN. DURING THE YEAR, THE ORGANIZATION SERVED 78 CHILDREN THROUGH ITS BLESSINGS IN A BACKPACK PROGRAM WHICH PROVIDED FOOD, BOOKS, AND TOOTHBRUSHES TO NEEDY STUDENTS.
