Projections are prepared by the Director of Student Administrative Services, delivered to the Director of Budget and submitted for approval to the Executive Vice President of Finance and the Board of Trustees. Various constituencies across campus are "allocated" a certain amount of funding to award to students, within the budgeted amounts. These awards are submitted to the Executive Vice President of Finance for approval and then routed to the Director of Student Administrative Services who then, through the Director of Financial Aid, oversees the packaging of these awards and integration with other financial aid awards to insure that no students with federal financial aid are over-awarded. Since these awards are tuition-based, they are posted to students' accounts each quarter once schedules are locked and total tuition amounts can be verified by the Director of Student Accounts and staff. Quarterly, the Director of Student Administrative Services compares actual expenses to budgeted amounts and alerts the budget manager of any potential overages. The budget is reviewed in each case to make sure overages will not cause fiscal issues. If it appears that they will, adjustments are recommended by the Director of Budget to the Executive Vice President of Finance.

virtual dissection lab, a review was done to compare student performance of students who used cadavers, students who used anatomy models, and of students who used the virtual dissection tables along with anatomy models to prepare for lab examinations in the Musculoskeletal Gross Anatomy course The scores were from nine consecutive academic calendar sessions over two years Results revealed that students that used the virtual dissection tables along with anatomy models performed better on average than the students that used cadavers only Faculty Achievements Full-time faculty member in the
