RESEARCH GRANTS ARE AWARDED TO GEORGIA STATE UNIVERSITY. Georgia State University is a premier urban public research university, solving global challenges in human health. Researchers utilize the University's state-of-the-art facilities and work across the disciplines to address critical quality of life issues, such as cancer, obesity, inflammation, vaccine development, child and adult literacy, and public health issues related to smoking, and other chronic diseases. For the first time in 2015, annual research awards received at the University exceeded the \$100 million milestone. This represents greater than a 40 percent increase in external research funding over the past three years. Federal sponsorship accounts for over 60 percent of the total research volume at the University.
