WE ALSO CARRIED OUT CONSERVATION PROGRAMS TO CONSERVE VITAL WATER AND LAND ADJACENT TO THE STREAMS AND RIVERS OF THE WATERSHED. CONSERVATION - WE WORKED WITH THE PIGEON RIVER FUND AND OTHERS TO INSTALL TWO NEW RIVER ACCESS POINTS IN THE URBAN ASHEVILLE AREA. ONE IS ON THE FRENCH BROAD RIVER GREENWAY RIGHT ACROSS AMBOY ROAD THE SMOKY MOUNTAIN ADVENTURE CENTER, FOR THEIR CUSTOMERS AND THE PUBLIC AT LARGE. THE OTHER IS AT PEARSON BRIDGE, BEHIND FRENCH BROAD OUTFITTERS, WHICH WILL ALSO BE USED BY THEIR CUSTOMERS AND THE PUBLIC. RIVERLINK BECAME AN ACCREDITED LAND TRUST BY THE LAND TRUST ALLIANCE, CONSERVING SPRINGS, WETLANDS, RIPARIAN AREAS, STEEP SLOPES, AND PUBLIC ACCESS TO RIVERS AND PARKS. RIVERLINK ALSO WORKS TO PROTECT SMALLER PARCELS THROUGHOUT THE WATERSHED THAT OTHER LAND TRUSTS MIGHT DEEM TOO SMALL. WE RECEIVED FUNDING FROM THE TENNESSEE VALLEY AUTHORITY TO
