CORE (formerly Several Dancers Core) is a professional dance organization that creates, performs, and presents contemporary dance, and is dedicated to opening channels of communication and education between artists and the community

For the year ended June 30, 2016, CORE operated the following programs (i) Community Engagement CORE operates a number of programs under its Community Engagement arm, including Dynamic X-Change (DXC), Teacher Training Institute (TTI), and Create Dance! CORE piloted the Teacher Training Institute (TTI) in 2006 working in collaboration with Atlanta Ballet, Moving in the Spirit, Dance Educators of Georgia, and ArtsConnect. Now CORE administers the program in Decatur and Houston. TTI sets the standard for excellence for teaching artists by developing the most qualified instructors in the region to teach dance and kinetic learning in a variety of community enrichment programs. Since 1992, Dynamic X-Change has been offered by CORE to our partner agencies in Atlanta and Houston, all nonprofits whose mission it is to help people overcome their obstacles and live more fulfilling lives. Dynamic X-Change provides safe, constructive, nurturing, creative outlets for young people, seniors and those who are isolated through situation or experience, building self-esteem, communication skills, healthy body awareness and dance appreciation. Focusing on self-expression and communication, as well as physical activity and fitness, class participants discuss and interpret their own life experiences through movement. DXC is CORE's most effective long term effort to reach broad segments of the community and it is consistently renewed by CORE's partner organizations. Create Dance! summer camp program for children and youth, created by the members of CORE Performance Company, is designed to bring out the dance artist in any child, no matter their age or experience level. By working with various art forms and methods as creative influences from visual arts to writing and even theatre children learn to develop ideas into their own, personally-made forms of creative expression. As they begin to recognize the dance in the world around them, participants learn to use these outside inspirations thoughtfully to create dance and performance that is unique to their experience. (ii) Fieldwork Inspired by and in partnership with The Field in New York, Fieldwork is a rigorous weekly, bi-weekly, or drop-in workshop designed to help artists of all disciplines gather information about their works-in-progress. For several weeks in the fall and spring, artists show developing works and receive candid, non-directive feedback from their peers. Fieldwork sessions are guided by experienced facilitators who are also creating work. At the end of the workshop, CORE presents a public showing of the works. (iii) CORE Performance Company Since 1980, CORE Performance Company has been creating and performing innovative contemporary dance. Known for its riveting, passionate and unique work, the CORE Performance Company has been internationally acclaimed in performance, tours and residencies in the U.S., France, Israel, Mexico, Guatemala, Sweden, Germany, Croatia and the Republic of Georgia. Critically acclaimed choreographer and CORE's Artistic Director, Sue Schroeders' vision was born in 1980 with CORE. In its home cities of Atlanta and Houston, CORE employs a company of 6 dancers each season and deploys them into opportunities for creation, performance, learning and teaching, all that well-rounded artists could wish, with a cadre of enthusiastic, skillful administrators, contractors and volunteers to support them. Feeling and information, whether the practice and lore of weaving in Mexico, the fluidity of painted masterpieces come to life, or the tragedy of domestic Japanese incarceration, the product is moving in every sense decades of connection and purposeful outreach to audiences that span generations, economies, tastes and cultures. (iv) Salon CORE embraces the idea that art is a conversation. During the fall and spring sessions, CORE presents an evening Salon. Audiences enjoy light refreshments as they observe art in creation and offer feedback in a facilitated setting. (v) Lunchtime in the Studio Sharing dance and lunch with the Decatur community, Lunchtime in the Studio showcases the many aspects of CORE in an informal setting. The audience gets a free lunch provided by local restaurant sponsors while enjoying a free dance event. (vi) Encore CORE is an annual program showcasing dance on film from local filmmakers in Atlanta and Houston, as well as contributions from the global field of dance on film. The line-up is curated by a selected panel, and the evening in both locations is highlighted as part of larger festivals. During CORE's first 30 years of operation, CORE performed for 300,000+ audience members (excluding major festivals). CORE toured to 63 cities in 4 countries, including 17 states in the U.S. CORE presented more than 80 guest artists from the U.S. and abroad and helped more than 400 artists develop their work. CORE paid 300+ artists for services. CORE reached approximately 12,000 students with its Dynamic X-Change Healing Arts Program (this is a conservative estimate) and has presented more than 300 workshops, classes and master classes. CORE's newly revised strategic plan, a work in progress to take effect in 2017, focuses on empowering the people within CORE with knowledge and connection, strengthening and stabilizing the structure that supports CORE's creativity, and streamlining the organization's systems of support so it can thrive in the next decades of the 21st century.
