Wesleyan is an independent K-12 grade school with a college preparatory curriculum There is a Lower, Middle, and High School located on 85+ acres with 8 main buildings, 10 faculty houses, 3 chapels, 2 libraries and 2 dining halls The Middle and High school employs a one computer tablet per student initiative The Arts programs utilize a 470 seat theater, a black box theater, drawing, painting and ceramic rooms, Middle and High School band rooms and Chorale studios, and 18 individual soundproof practice chambers For Athletics, there are 4 gyms, 11 tennis courts, football, baseball and softball stadiums and track, a 10 lane 2 dive well Natatonum, 2 beach volleyball courts, 2 weight rooms, and large fields for soccer and lacrosse Also there is a full cross country track situated around campus Now present are an enlarged High School Chapel, new athletic fields, and a Lower School addition that provides meeting and other spaces Starting enrollment for the school year was 1138 students The 2016 graduating class numbered 112 The class received \$8,225,422 in scholarship offers from 99 colleges
