PRIMARILY ACADEMIC CONSIDERATIONS ARE FACTORED INTO THE SELECTION OF THE WINNER, THOUGH STUDENTS NOT ALREADY HOLDING OTHER MAJOR SCHOLARSHIPS ARE GIVEN AN ADVANTAGE IN THIS COMPETITION. THE ETHNICITY, RACE, RELIGION, NATURAL ORIGIN AND OTHER PROTECTED CLASS STATUS OF APPLICANTS ARE NOT CONSIDERED NEGATIVELY OR POSITIVELY IN THE AWARDING OF THESE SO-CALLED "ACADEMIC EXCELLENCE" SCHOLARSHIPS. ON OCCASION, THE CROFT INSTITUTE AWARDS A SCHOLARSHIP OF UP TO \$9,000 PER YEAR TO AN INTERNATIONAL STUDENT APPLICANT FOR ITS INTERNATIONAL STUDIES MAJOR. THE GOAL OF THIS PROGRAM IS TO GIVE CROFT STUDENTS INTERNATIONAL PEERS WHO ARE IN THE PROGRAM FOR THREE OR FOUR YEARS. APPLICANTS ARE SELECTED ON THE BASIS BOTH OF PAST ACADEMIC PERFORMANCE AND FINANCIAL NEED (AS FAR AS THE LATTER CAN ACCURATELY BE DETERMINED). STUDENTS FROM EAST ASIA, EUROPE AND LATIN AMERICA ARE GIVEN PREFERENCE, AS CROFT STUDENTS ARE REQUIRED TO CONCENTRATE A MAJOR PORTION OF THEIR STUDIES ON ONE OF THESE THREE REGIONS OF THE WORLD.
