devastating threats to agriculture, as it attacks more than 430
different commodities. The meetings were held to keep everyone up
to date on the steps being taken to eradicate this threat. It
took several months of hard work and close coordination of
federal, state, local offices and industry partners to contain
the outbreak which were successful.

Dade County Farm Bureau participated in the Annual Miami
International Agriculture Horse & Cattle Show. Each year we bring
agriculture to the urban area of Miami Dade County. This year we
created an Ag Venture for visitors of all ages to participate. We
partnered with Miami Dade County Extension Services, 4-H, University
of Florida, USDA, Florida Department of Agriculture and local
growers. The Ag Venture provided an opportunity to showcase South
Florida agriculture with a farmer's market and locally grown produce
from South Dade High Students FFA.

Dade County Farm Bureau hosted several Town Hall meetings to inform
our members and community on the flooding issue caused by the rain
