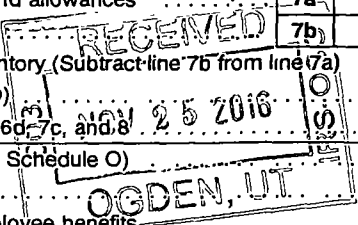

28) In November, we participated in Farm City Week held at Heritage Village in Largo. Our volunteers in conjunction with FNGLA, UF/IFAS, FFA, and the Pinellas County Government were able to serve over 500 people. This years theme was small farm animals. There were multiple commodity stations set up for hands on experiences. These stations included ice cream making, butter and squeezing orange juice. There were also games and small animals. Animals included rabbits, chickens, alpacas, a mini horse and goats. This event gives us the opportunity to educate the urban population about the importance of agriculture.

29) Each year we co-sponsor the annual State Floriculture and Nursery/Landscape career development day. The event is attended by students, advisors, and volunteers. At school, students are taught the fundamentals and then are given the opportunity to demonstrate what they have learned through projects and testing. The purpose of this event is to help students gain practical knowledge about the industry.

30) In a cooperative effort with the Madeira Beach Recreation Center, we have a garden club where we use lesson plans from the Sunshine State Standards to educate students on Florida agriculture. Students plant, care for, and harvest different crops based on the growing season. This program allows students to gain an appreciation of agriculture, learn to identify various plants, and become good stewards of our land.
