



	Outpatient programs - with a dedicated network of licensed psychiatrists and counselors, Centerstone of Florida offers extensive outpatient mental health services to adults and children throughout the span of their lives When life just can't be put on hold, Centerstone of Florida offers a way for adults to get the help they need for alcohol and drug addiction often while continuing to maintain employment and live at home with loved ones Our intensive outpatient programming is designed to assist in continued recovery from alcohol, drugs, or those with co-occurring mental health concerns with services that include group and family counseling and marital and couples therapy We also provide physician assisted medical detox from opiates and pain medication through Suboxone treatment Centerstone also addresses the challenges youth face in growing up alcohol and drug free Youth learn they are not alone We address co-occurring, mental health and trauma providing family support and parenting assistance For those suffering from severe and persistent mental health issues, the Centerstone of Florida Florida Assertive Community Treatment (FACT) Team delivers comprehensive treatment, rehabilitation and support services that allow individuals to live successfully in the community The team provides a "hospital without walls" utilizing a positive, persistent and practical approach in providing immediate crisis response, medication management, assistance with household tasks and supportive therapy Almost one third of our clients are children and adolescents With that in mind and in keeping with our commitment to helping children in crisis, Centerstone of Florida offers services designed to work with families and schools to support a child's success and prevent future need for mental health services Outpatient services are provided by licensed child psychiatrists and youth counselors to fit the needs of each child and their family For children experiencing severe emotional issues, the Centerstone of Florida Children's Community Action Treatment (CAT) Teams provide services including assessment and case management, therapy, crisis intervention, respite services for the child, parent and siblings, parenting skills, family support network development, family education and education system advocacy Centerstone of Florida through its partnerships with local Court Administration offers jail diversion programs servicing Manatee and Sarasota Counties Forensic services are also provided in the Manatee County Jail system for inmate behavioral health needs

	Inpatient & residential program - Centerstone of Florida is a specialty hospital and outpatient practice for mental health and addictions Centerstone of Florida hospital and addiction center provides state-of-the-art care for adults and seniors Our hospital is a 37-bed, private behavioral health facility providing brief inpatient stays during an emotional crisis Hospital services include effective treatment for anxiety disorders and phobias, alcohol and substance abuse detox, schizophrenia, post-traumatic stress and acute stress disorders, obsessive compulsive disorders and major depressive disorders The Centerstone of Florida Addiction Center allows clients to medically detox with dignity as they begin their recovery in relaxed and private surroundings Our 24 bed Addiction Center then offers residential services for adults needing substance abuse treatment to continue their recovery The Addiction Center gives individualized care to men and women in a safe, serene environment The program provides interventions, detox services, 12-step integration, psychiatric services, art and music therapy, and family recovery groups Residents are offered the chance to learn, reflect and find serenity in an atmosphere that also includes loved ones in the treatment process Our 31-bed Crisis Stabilization Unit assists children and adults when in the midst of a mental health or substance abuse crisis We offer 24-7 medical monitoring, and clients are housed in a safe and secure environment Medication management and therapy are provided as well as any necessary case management services to assist in step-down care

	Child welfare program - more than 300 children and their families each year depend on Centerstone of Florida to help reunite their families One reason parents may neglect or abuse their children is because of their own alcohol and substance abuse By treating the parent and the child, Centerstone of Florida is able to provide the whole family with the care needed for a safe and happy reunion We provide case management, prevention diversion and medical case management for children in foster care and their families Through our collaboration with the Safe Children's Coalition, we offer a holistic plan for helping families affected by mental health and addiction issues Unfortunately there are children and adolescents who can't return home The Centerstone of Florida adoption preservation program provides counseling and support services to children ages 3 to 17 and their families who have either been adopted or are in the adoption process

The Community encompasses 725 square miles. Sarasota County population is approximately 390,000 permanent residents and approximately 476,000 during the winter months (Sarasota County 2015). Based upon 2010 U.S. Census data, the total population of Sarasota County was 379,448, an increase of 16.4 percent since the 2000 Census data was reported. Population data was gathered from the U.S. Census for the years 1900-2010 for Manatee County and incorporated communities. Like much of South Florida, Manatee County has seen strong continuous growth. Over the past century, the Countys population has grown from 4,663 people in 1900 to 322,833 at the time of the 2010 Census. The Countys population is projected to continue its strong growth and increase in population by approximately 95,000 residents during the next 20 years. In addition to its permanent population, Manatee County has a significant seasonal influx that increases its population during the November to April season of an estimated 30%. (Manatee County 2012) Manatee Countys population has a much older age structure than the United States or the State of Florida. In 2010, the Countys median age was 45.7 years, as compared to 37.2 years for the Nation and 40.7 years for Florida. Manatee County had 30.5% of its population over the age of 60, while the U.S. was half that rate at 18.5%, and Florida as a whole was at 23.4%. In 2012, Sarasota County reported 32.5% of its population was over the age of 65. According to the 2010 U.S. Census, approximately 81.9% of the population reported their race as White and approximately 8.7% of the population reported their race as African American. This accounts for the mass majority of Manatee Countys population (90.6%). The 2010 U.S. Census reports 91.2% of the Sarasota County population to be White, 8.4% Hispanic and 5% to be African American. Manatee and Sarasota Counties income statistics are comparable to the State. According to the 2010 U.S. Census, Manatee Countys median household income is \$47,876, Sarasota Countys median household income is \$49,212 while Floridas was \$46,956. As compared to the national household income, Manatee County, Sarasota County and Florida reported just under the National Median Income of \$51,914. Low income is defined as those who have an income of less than 50% of Area Median Income. According to the 2010 American Community Survey three-year estimates, the poverty rate for all individuals in Manatee County in 2010 was 13.6% and Sarasota County reported 11% as compared to 15.0% for Florida and 14.4% for the U.S. The most alarming statistic is the high rate of poverty among families headed by women with children living in the home (25.1%). Equally disturbing is the high rate of poverty among children (40.6% for all children under 17).</p>
